- F. That skeletal fragments were found approximately one fourth of a mile from his home in a heavily wooded area and which were examined and determined to be those of a ten to fourteen year old person.
- G. That pieces of clothing were found approximately one fourth of a mile from decedents residence which resembled clothing he was wearing when last seen.
- H. That the temperature was approximately 40 degrees fahrenheit on the night of 10-31-81.


